Telecom Regulatory Authority of India (TRAI) released a Consultation Paper regarding Regulatory Mechanism for Over-the-Top (OTT) Communication Services and Selective Banning of OTT Services. Last date to submit the comments was 01-09-2023. Draft comments were circulated to all members and industry partners for valuable inputs. After examining and consolidating the inputs, the IAFI submitted its detailed views on the various issues raised in the consultation paper to TRAI on 31st August 2023.
