Dinner Reception in rcognition of former Member (T) and welcoming new



ITU-APT Foundation of India (IAFI) organized a Dinner Reception on 04th April, 2024, to bid farewell to Ms Gunjan Dave, former Member (Technology) and to welcome newly appointed Member (Technology), Ms Madhu Arora, at CSOI, KG Marg, New Delhi. Ms. Gunjan Dave, a distinguished ITS officer, recently retired from the DoT on 31-03-2024, after a remarkable 37-year career. Ms Madhu Arora joined as Member (Technology), DCC, DoT on 01-04-2024. Prior to this, she served as CGM, Telecom West Bengal circle from September 2021 to January 2024 and joined as Sr DDG (Licensing), DoT HQ on 01-01-2024. She hold a Bachelor degree in Electronics and Communication from Delhi College of Engineering, an MBA from the University of Queensland, and an LLB from Campus Law Centre, Delhi University. She joined as an ITS officer in 1986 batch, a batch topper.



IAFI President, Shri Bharat Bhatia, in a statement to the PTI applauded the TRAI's decision to release a consultation paper on auction of the 37-37.5 GHz, 37.5-40 GHz, and 42.5-43.5 GHz bands, as these millimetre wave bands hold immense potential for 5G and future 6G deployments. These high capacity bands are ideal for dense small cell networks, which are vital for ensuring reliable and widespread 5G coverage in sectors like healthcare, robotics, and Industry 4.0. TRAI on 04-04-2024, released a Consultation Paper for seeking the views of the stakeholders on the auction of these three new spectrum bands for mobile cellular services. The regulator has sought comments on pricing, validity, preferred block size, spectrum caps, allocation norms, rollout obligations, and other terms and conditions and payment terms etc. TRAI has requested stakeholders to submit written comments on the issues raised in the consultation paper by May 2, 2024, and countercomments by May 16, 2024.

DoT has deferred the scheduled spectrum auction for 5G services due to general election



Department of Telecommunications (DoT) decided to defer the upcoming spectrum auction by 17 days to June 6, 2024, due to the general election in the country, which was earlier scheduled to start from May 20. Similarly, the mock auction will now be conducted on June 3 instead of May 13-14, 2024. The Department of Telecom had announced the schedule for the upcoming spectrum auction for 5G services in eight bands on 8 th March, 2024. In February this year, the Union Cabinet had approved the auction in eight frequency bands 800 MHz, 900 MHz, 1800 MHz, 2100 MHz, 2300 MHz, 2500 MHz, 3500 MHz, and 26 GHz bands.
