

IAFI Radio Group Meeting for preparation for the upcoming WP-5D:



IAFI Radio Group meeting was held on 16-01-2024, in hybrid mode, to discuss the contributions to be submitted by IAFI in the upcoming 45 th WP-5D meeting, which is likely to be held from 31-01-2024 to 07-02-2024 at Geneva, Switzerland. Seven contributions were finalized and submitted to TSB for further necessary action. All contributions have been uploaded on the ITU website as detailed below.

IAFI inputs to the APT WTSA-24 Preparatory Group meeting:





IAFI took a proactive approach to the WTSA-24 meeting by developing 16 impactful contributions on key resolutions. These contributions address diverse topics with the potential to significantly shape the future of telecommunications in the region. To ensure comprehensive representation, IAFI strategized at the First National Preparatory Workshop held on January 10th, 2024, at CSOI, KG Marg, New Delhi, in collaboration with TEC/DoT. It was decided that eight of these contributions would be submitted through TEC, maximizing their reach and impact, while the remaining eight would be directly submitted to APT, ensuring IAFI's distinct voice is heard.

So eight contributions developed by IAFI on WTSA-24 Resolutions – 64, 68, 73, 79, 92, 93, 97 and 98) were sent to TEC to submit as India's contribution and eight contributions on Resolutions- 7, 20, 47, 58, 60, 75, 88 and 92 will be submitted to APT directly.

India's Mobile Phone Manufacturing and Export reached to a new height:



India's mobile phone industry is surging, poised to reach a record \$50 billion (Rs 4,156 billion) in production value for FY24. Simultaneously, exports are projected to skyrocket to \$15 billion (Rs 1,247 billion), solidifying mobile phones as India's fourth largest export category. Notably, Apple's smartphones constitute a significant 65% of these exports. This remarkable growth signals India's burgeoning role as a global mobile phone manufacturing and export hub.

The messages are sent through a communication satellite and received at a central control station (INMCC: Indian Mission Control Centre) where the alert signals are decoded for the identity and location of the fishing boat. The extracted information is forwarded to Maritime Rescue Co-ordination Centres (MRCCs) under Indian Coast Guard (ICG). Using this information the MRCC co-ordinates to undertake Search and Rescue operations to save the fishermen at distress. The DAT is operational since 2010 and till now more than 20000 DATs are being used
